Shooters Must Provide Their Own Staple Gun And Staples
Please Read The Rules On The Reverse Side

L.V.P.R.L. RANGE RULES

1. No Alcoholic Beverages may be consumed before or during league shooting.
 2. Follow Range Officers instructions at all times.
 3. Never load any gun before the command is given.
 4. Always keep muzzles pointed down range.
 5. Make sure chambers are clear, magazine removed and action open, when instructed to do so.
 6. Always insert Plastic Tie (Empty Chamber Indicator) into the chamber or barrel, before you go down range to score.
 7. Never handle any gun when someone is in front of the firing line.
 8. Hearing and Eye Protection are mandatory.
 9. No Magnum Ammunition allowed, target loads only.
 10. Live rounds (misfires) must be placed in the misfire can on the range officer's podium.
 11. Shooters may enter the range during the relay before their first relay. They should place their closed containers behind the yellow ready line and await the range officers command to move equipment to the line. All guns must be unloaded.
 12. Never advance in front of the firing line until instructed to do so by the Range Officer.
 13. If you are ever unsure concerning any safety matter, ASK THE RANGE OFFICER!
 14. The Range Officer will deal with any safety matters that arise that are not covered in the above rules. The Range Officer has the Final Word. These matters will then be taken up with the B.O.D.
 15. In any case, the Range Officers word is LAW! In case of repeated or major infractions of the rules, the Range Officer is empowered to order the shooter to leave the line.
 16. New Members must successfully complete New Member Orientation before shooting for the first time.
 17. Novice shooters may only shoot a .22 caliber target pistol.
