

## Hellertown Sportsmen's Association, Inc. (HSA) New Membership Application Procedures

### **INSTRUCTIONS and REQUIREMENTS for PRIMARY MEMBERSHIP**

- Fill out and sign the HSA Club copy (page 1).
- Prospective Primary members must attend the Safety Meeting + two membership meetings or one membership meeting and one activity.
- Bring the two-page application to a monthly Membership Meeting along with the appropriate fee and required photo ID. Present these to the Membership Secretary at the beginning of the meeting.
- Attend a second meeting or actively participate in one of the following HSA Club sponsored activities: **ARCHERY – ACTION PISTOL – LVPRL – TRAP – HSA HOSTED FIREARMS TRAINING COURSE**.
- Secure the Club activity representative's signature on the Applicant Copy (page 2) to confirm your participation. You will retain and present this page throughout the application process.
- Attend an HSA Safety Orientation Class. (*Note: The Safety Orientation Class may be attended before the other required events. You must register for the class by email to [marabob0118@verizon.net](mailto:marabob0118@verizon.net) or call (484-358-5672)*). Secure the instructor/range safety officer's signature on the Applicant Copy (page 2) to confirm your attendance and passing the examination.
- Once all of the above is completed, submit the application to the Membership Secretary at a monthly Membership Meeting or by mail.
- Receive your membership card after being voted in at a monthly Membership Meeting.

### **INSTRUCTIONS and REQUIREMENTS for SPOUSE & JUNIOR MEMBERSHIP**

- A Spouse or Junior Member must be under the supervision of a Primary Member when using the Club ranges and facilities.
- Any Spouse wanting to use the Club ranges and facilities without Primary Member supervision must apply for Primary Membership and follow the above procedure.
- A Junior Member is age 15 and under; must provide their date of birth on application and must be signed by parent or guardian.
- A Junior Member reaching the age of 16 must attend an HSA Safety Orientation Class in order to advance to Primary Membership.

### **HSA RULES for MEMBERS' USE of FACILITIES**

- No applicant may use the HSA Club facilities until they have completed the membership process and have received their membership card.
- No Guests are permitted to shoot or handle firearms on Club property. All guest must wear eye and ear protection while observing any shooting.
- Any Member allowing a Guest to shoot or handle a firearm will lose their membership privileges.

1. *At the Meeting:* Bring cash or check payable to Hellertown Sportsmen's Association with this completed form and photo ID for the Primary member only. All applicants must have a Sponsor who has been a PRIMARY member of HSA for at least one year.
2. Applicants for Primary Membership must attend two of the Club events listed below. These include the monthly Membership Meetings and participation in any of the organized Club activities. Applicants must have the Membership Application signed below by the person in charge or a designee of the events attended.
3. All applicants for Primary Membership must also attend a Safety Orientation class before they will be issued their membership card. Classes are normally held at 5:30 PM on the third Tuesday of every month prior to the monthly Membership Meeting. Any additional classes will be posted on our website at [www.hellertownsportsmen.com](http://www.hellertownsportsmen.com).
4. Once all of the above is complete, submit the Applicant Copy (this page) to the Membership Secretary.
5. Receive membership card after being voted in at the monthly Membership Meeting.

A Spouse/Junior membership with Primary member supervision is required for the use of the Club facilities and all ranges. Applicants cannot use the ranges unless actively participating in a supervised Club activity to satisfy the pre-membership requirements.
